

All illustrations are presented in full color, including new medical-legal drawings for instruction and courtroom testimony. I have worked as a crime scene investigator for some 15 years and am now a police academy director. This text is the "Bible" for those of us who investigate murder--there is no better collection of information available. I also recommend Lt. Cmndr. Geberth's course offered throughout the United States under the same title. Get this, but don't leave it laying around--some cop will steal it!
